A recent edition of Poet Connections hit the college campus. Were you surprised by all the "news"? You should be. The WASC accreditation Committee found no real evidence of any substantial long-term planning. Enrollment is down, donations/giving is down (and will drop dramatically this year because of the President's ill-advised cuts), assets are being sold which are one time funds to support ongoing programs, there has been little to no transparency, the faculty show no support for this President, the AAUP has a very negative response to all that this President has done (none of which is positive), large Grants are siphoned off and sent to her son and her favorite administrators with no planning or accountability for the funding.
